Some people say whatever they can to be elected. They yell **“The Sky is Falling”** and point to misleading charts and graphs, knowing if they scare you enough, you will vote for them. The truth is, we need to be aware - not scared. The benefit of a candidate with experience, is that **Betty Lin Peterson** understands the big picture, how government actually operates, and the time required to develop the best course of action to solve our city's financial difficulties.

**Chicken Littles: “Our city is headed for immediate insolvency”** They pull out a mislabeled chart showing our city is headed for bankruptcy. What is not reflected is that this chart includes depreciation which requires no further outgoing cash flow.

**Chicken Littles: “Pension debts will bankrupt the city.”** They fail to mention that Palos Verdes Estates' pension to revenue ratio is 3.5% which puts us better than 70% of California cities, and that at 80.1% our pension funding ratio is better than 86% of the state. Palos Verdes Estates prepays portions of the unfunded pension liability every year, to avoid interest and achieve greater long term savings.

**Chicken Littles: “Incumbents increased spending by 23%.”** They fail to tell you that the city incurred millions of dollars of unfunded state mandates, amid stagnant revenue growth during the recession. Furthermore, the failure of Measure D decreased revenues by 25%. Responding to new financial realities, the incumbents reduced city expenditures by \$1.3 million.

On March 5th, don't vote for scared chickens, vote for **Betty Lin Peterson**, the candidate that has guided our city through tough times, reduced our spending, kept our local police and local control, and created committees to utilize residents' expertise.
